Qualified medical provider (QMP) patient limits have changed

During the 2023 legislative session, the number of medical cannabis recommendations that a QMP can provide changed. Now, QMPs can recommend medical cannabis to the number of patients that is equal to 1.5% of the total number of registered medical cannabis patient cardholders. If a medical provider receives payment from a patient's insurance plan for services, then the patient whose insurance plan was billed does not count toward the 1.5% patient cap. The patient cap will be set quarterly during each calendar year.

- As of October 1, 2023, the patient limit for all QMPs has been updated to 1,093.


Medical Cannabis Policy Advisory Board meetings

The Medical Cannabis Policy Advisory Board is a new 9-member board consisting of different stakeholders. Its meetings are open to the public and are hosted by the Utah Department of Health and Human Services (DHHS). DHHS and the Utah Department of Agriculture and Food (UDAF) staff members attend board meetings. After listening to public comment, the board voted to recommend that UDAF make the following changes to administrative rules:

- Require that medical cannabis capsules, gummies, liquid suspensions, tablets, and tinctures include the amount of total THC and any advertised cannabinoids on the product's fact panel, listed in milligrams per serving.
- Limit medical cannabis products to include no more than 2 seeds per 3.5 grams of unprocessed cannabis flower.
- Ban the presence of hexahydrocannabinol (HHC), tetrahydrocannabinol acetate (THC-OAc), and 3-heptyl-delta(1)-tetrahydrocannabinol (THCP) in medical cannabis products.

UDAF is considering these recommendations and will soon draft and file any proposed rule changes. General information about the board can be found here:

Utah Department of Agriculture and Food (UDAF) now oversees medical cannabis pharmacies and medical cannabis couriers

During the 2023 Legislative Session, HB72 was passed. HB72 makes it so that UDAF takes over most regulatory authority over medical cannabis pharmacies. Here's what this means for you:

- For patients and medical providers, nothing changes. You will still use the EVS to submit and manage your medical cannabis recommendations.
- For medical cannabis pharmacists, nothing changes. DHHS will still oversee all medical providers, which includes you. DHHS oversees your continuing education and your medical cannabis pharmacist registration.
- For medical cannabis pharmacy and couriers, UDAF oversees facility compliance visits, continuing
 education, and your medical cannabis pharmacy agent or courier agent registration. If you have

Utah Department of Agriculture and Food (UDAF) Cannabis Production Establishment Licensing Advisory Board meetings



Medical cannabis education

Have you ever been curious about your rights as a medical cannabis patient? We have some helpful information to understand the laws about driving and medical cannabis. In the next few quarterly updates, our medical cannabis education will focus on the different parts of Utah medical cannabis laws.

Transporting medical cannabis



*Legal limit: 113 grams of unprocessed cannabis (flower); and 20 grams of THC in all other forms, like gummies, tinctures, vape cartridges, etc.

What happens if I forget my card and I get pulled over?

If a law enforcement officer stops you in the state of Utah and you have medical cannabis products or devices on you, but don't have your medical cannabis card, the officer must attempt to access the state electronic verification system (EVS) to verify whether you have an active medical cannabis patient card.

If the officer is able to verify that you have an active medical cannabis patient card, then the officer may not arrest you only for having medical cannabis products or medical cannabis devices with you. Additionally, the officer may not seize your medical cannabis product or device.



Research and data

DHHS data reporting

For quarter 3:

- The number of active medical cannabis cardholders increased by 1% from 71,850 patients in June to 72,370 in September.
- The number of QMPs decreased by 5 to 954 total QMPs between June and September.
- Most medical patients are between the ages of 31-40 years.
- There has been an increase in new patients since August.

As of September 2023, there are:


- 8 medical cannabis cultivators who are allowed to cultivate medical cannabis.
- 1 tier-2 processor who is allowed to package and label medical cannabis products.
- 14 tier-1 processors who are allowed to process, formulate, package, and label medical cannabis products.
- 1 testing lab licensee who tests medical cannabis products before they're sold.
- 15 medical cannabis pharmacies who are allowed to sell products directly to patients.


Operations

DHHS Center for Medical Cannabis received 18 complaints in the 2nd quarter.

Utah Medical Cannabis Visit Cost website

Medical cannabis patients should be able to know the cost of their medical visits and have the opportunity to find the right care at a reasonable price. The Medical Cannabis Visit Cost website (https://healthcost.utah.gov/cannabis.php) helps patients compare prices charged by qualified medical providers (QMPs) for initial and renewal medical cannabis evaluation visits. Here's what you need to know about the site:

- QMPs and medical clinics are required to report their fees if they represent online or in printed materials that they offer medical cannabis evaluations.
- The fees posted are estimates. Always contact the clinic or your insurance provider to confirm what your out-of-pocket costs will be.

Are there incorrect prices listed? If you notice a price posted on the website is significantly different than the price actually charged by a clinic, you can submit a complaint at https://forms.gle/TiCGp1axn6iKj2md9.

• You'll need to provide the name of the QMP you met and the name and address of the clinic where you met with them.

Utah Subsidy Program from Utah Patients Coalition

You may qualify for financial help to pay for medical cannabis. The Utah Patients Coalition has a Utah Subsidy Program that assists with many costs associated with medical cannabis.

- This program can subsidize the following costs:
 - Medical consultations and doctor visits.
 - Medical cannabis products and devices.
 - DHHS electronic verification system (EVS) fees.
 - Cannabis home delivery costs.
- In order to qualify, you must provide:
 - Proof of Utah residency.
 - Proof of financial eligibility.
 - Proof of a qualifying medical condition for medical cannabis.
 - Proof of registration or intent to register as a cardholder with the DHHS Center for Medical Cannabis.
